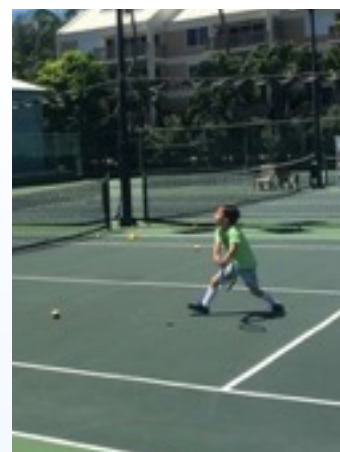
The three day camp schedule provides great support to young sailors as they gain confidence on the water. Children will work in small groups at their
